## **Minutes**

### **Public Hearing on Proposed 2022 Budget**

- ❖ The public hearing on the proposed 2022 budget was called to order by Chairman Meldon Maguire at 7:00 PM. The hearing was held at the Town of Emmet Garage. The Clerk read through the budget items and highlighted the changes from last year's budget. Those included additional money for the Town reassessment and money for possible capital outlay. No changes were made to the budget as presented. Expenditures for certain projects might have to be adjusted depending upon revenues and project costs. Motion by Tyler Dahlke, second by Rob Clint to adjourn the budget hearing. Motion carried.

### **Special Town Elector Meeting**

- ❖ Chairman Maguire called the Special Town Elector Meeting to order. The proposed 2022 budget and the 2022 Town of Emmet levy of \$145,612.00 were presented to the electors present. There was no discussion. Motion by Mike Hafner, second by Rob Clint to approve the proposed budget and Town levy. Motion carried. Motion by Tyler Dahlke, second by Rob Clint to adjourn the Town Elector Meeting. Motion carried.

### **Regular Monthly Town Board Meeting**

- ❖ Chairman Maguire called the Regular Monthly Town Board Meeting to order at 7:10 PM. The meeting was held at the Town of Emmet Garage. All Town Board Members were present. Also present was Mike Hafner.
- ❖ Motion by Rob Clint, second by Tyler Dahlke to approve the printed minutes of the October 13, 2021 regular Town Board meeting. Motion carried.
- ❖ Treasurer Mike Maguire presented the financial report for November 2021. Motion by Dahlke, second by Clint to approve Treasurer's report. Motion carried.
- ❖ Motion by Clint, second by Dahlke to approve payment of bills with check numbers 17883 through 17896, wages, and bills paid online. Motion carried.
- ❖ Clerk's Report:
  - There were two building permits issued - Bill Maguire, bathroom addition to house; and Steve Michlig, house/shed. The building being constructed by Michlig will not be completed until 2022.
  - The Clerk reported to the Board a complaint by a Town resident regarding dust on Schuette Road.
  - The final shared revenue payment will be received on November 15, 2021.
- ❖ Motion by Dahlke, second by Clint to approve the 2022 budget and Town levy as adopted at the Special Town Meeting. Motion carried.
- ❖ Chairman/Supervisor Reports:

- The issue of nails being thrown on Pelican Bay Drive was discussed by the Board. The cost of installing surveillance cameras will be looked into. The Board will then make a decision regarding installation.
- The Board discussed the issue of unchained dogs and other animals roaming freely on Hillwood Drive.
- The access trail on Bayside subdivision was discussed and Board members will contact a landowner for a possible alternative trail.
- The large culvert on Still Hill Road was replaced today (November 9, 2021). The Clerk will pay the vendor and contractor upon receipt of the bill.
- ❖ Motion by Dahlke, second by Clint to renew the agreement with the Town of Green Valley for usage of gravel/salt for the 2021/2022 snowplowing season. Motion carried.
- ❖ Motion by Clint, second by Dahlke to set the next meeting date for December 14, 2021, at 7:00 PM in the Town of Emmet Garage.
- ❖ Motion by Dahlke, second by Clint to adjourn. Motion carried. Time: 8:46 P.M.
