Minutes

Regular Town Board Meeting June 9th, 2026

- ❖ The regular monthly Town Board Meeting of the Town of Emmet was called to order on the above date by Chairman Tyler Dahlke at 7:01 PM. The meeting was held in the Halder Community Hall, 135125 Halder Drive, Mosinee, WI. Present were Town Board members Tyler Dahlke, Lisa Baur, Dan Knetter, and Jerry Fitzgerald. Also present was Frank Feehrer.
- ❖ The Pledge of Allegiance was recited.
- ❖ Motion by Lisa Baur, second by Dan Knetter to approve the printed minutes of the May 12th, 2026 Town Board meeting. Motion carried.
- ❖ In the absence of Treasurer Mike Maguire, the Clerk gave a brief financial report for June 2026. The Treasurer had furnished the Board with a transaction report and financial statement. The major bills were the payment for dust control and Harter's. Motion by Baur, second by Knetter to approve the financial report and payment of bills with check numbers 19206-19227, wages, and payments made electronically. Motion carried.
- ❖ Clerk's Communications & Reports:
 - There were four building permits issued since the last meeting:
 - Brian King - shed
 - Mike Maguire - patio
 - Jacob Zernicke - house addition and attached garage
 - Rock Ridge Orchard - outdoor stage
 - The Clerk has filed a disaster claim for snow damage from March and a disaster claim for flooding in April 2026. The state has received the snow damage claim and is processing it. The claim for flooding is dependent upon FEMA authorization.
 - Three loads of dust control have been applied throughout the Township.
- ❖ Motion by Baur, second by Dahlke to approve the liquor licenses for Rock Ridge Orchard and Safari Bar. Motion carried.
- ❖ The Board has approved lowering the speed limits on the following Town roads: Twin Creek Road, Cardinal Lane, and portions of Sugar Bush Road. Motion by Baur, second by Knetter to order the necessary signs.
- ❖ Motion by Knetter, second by Baur to install a new culvert on Long Drive, do necessary ditching, and apply hard rock to the road. Motion carried.
- ❖ The Clerk informed the Board of some questions by prospective land buyers regarding construction of duplexes for residence. No Board action was taken. If the situation arises, the planning commission will need to do a rezone.
- ❖ Chairman & Supervisors' Reports:
 - The large culverts for Shuette Road and Maple Leaf Road will be ordered as soon as Marathon County authorizes the sizes for the culverts. The culvert replacements on Burns Creek Road will depend upon the size that Marathon County mandates.
 - WPS will be putting new wiring into the Town Hall. The Town will work with a local electrician to set up new equipment to service the new line.

- ❖ Motion by Baur, second by Knetter, to set the date for the next Town Board meeting for Tuesday, July 14th, 2026, at 7:00 PM at the Halder Community Hall. Motion carried.
- ❖ Motion by Knetter, second by Baur to adjourn. Motion carried. Time - 8:02 PM.
