Minutes

- ❖ The regular monthly Town Board Meeting of the Town of Emmet was called to order on the above date by Chairman Tyler Dahlke at 7:04 PM. The meeting was held in the Halder Community Hall, 135125 Halder Drive, Mosinee, WI, the meeting being changed due to a scheduling conflict. Present were Town Board

members Tyler Dahlke, Lisa Baur, Dan Knetter, Mike Maguire, and Jerry Fitzgerald. Also present were Steve Stankowski and Shannon Baumann.

- ❖ The Pledge of Allegiance was recited.
- ❖ Motion by Lisa Baur, second by Dan Knetter to approve the printed minutes of the November 11, 2025 budget hearing, Town elector meeting, and the regular town board meeting. Motion carried.
- ❖ Treasurer Mike Maguire presented the financial report for December 2025. Because of the early meeting date, there will be more bills to be paid before the end of the year. Motion by Knetter, second by Baur to approve the Treasurer's report. Motion carried.
- ❖ Motion by Baur, second by Knetter to approve payment of bills with check numbers 19043 through 19059 wages, and payments made electronically, and other bills and wages that arrive after this meeting date. Motion carried.
- ❖ Clerks Communications and Reports:
 - No building permits issued.
 - Tax rates have been sent to Marathon County. The Treasurer will be notified when the taxes are printed.
 - Harter's will furnish the garbage schedule for next year. It will then be put on the website.
 - PASER ratings were done today and submitted to the state.
- ❖ Motion by Knetter, second by Baur to renew the agreement with Green Valley for their purchase of gravel/salt from the Town of Emmet. Green Valley will be billed at the end of the winter season. Motion carried.
- ❖ Motion by Baur, second by Knetter to approve the fire and ambulance contract with the Mosinee Fire
- ❖ District for a five-year period beginning January 1, 2026 in the amount of \$15,950 for ambulance service per year and \$8,800 for fire protection per year. Motion carried.
- ❖ Motion by Baur, second by Knetter to appoint the following to serve as election inspectors for the 2026-2027 term: LeeAnn Thomsen, Rosalie Michlig, Cindy King, Donna Kaiser, Donna Kijak, Holly Stankowski, Jane Doll, and Brad King. Motion carried.
- ❖ After Board discussion, motion by Knetter, second by Baur to accept the quote of Community Insurance for 2026. This motion is contingent upon some issues from Community Insurance regarding coverage being resolved. Motion carried.
- ❖ Chairman/Supervisor Reports:
 - Two culverts were replaced on Fairview Road. The Clerk will pay the contractors when all bills are received.
 - The Halder Community Club Christmas Craft Show will be on Sunday, December 7, 2025.
 - Asplund Tree Cutting Services will be trimming branches on Mallard Lane and Still Hill Road.
 - Motion by Knetter, second by Baur to support a proposal by Marathon County CPZ regarding heights of property and privacy fences. Motion carried.
- ❖ Public Comments:

- A landowner had a concern about hunters and other personnel trespassing on his property to access Town-owned land.
- ❖ Motion by Baur, second by Knetter to set the date for the next Town Board meeting on Tuesday, January 13, 2026, at the Halder Town Garage. Motion carried.
