## **Minutes**

January 13th, 2026

### **Regular Town Board Meeting**

The regular monthly Town Board Meeting of the Town of Emmet was called to order on the above date by Chairman Tyler Dahlke at 7:00 pm. The meeting was held in the Halder Community Hall, 135125 Halder Drive, Mosinee, WI. Present were Town Board members Tyler Dahlke, Lisa Baur, Dan Knetter, Mike Maguire, and Jerry Fitzgerald. Also present were Steve Stankowski and Shannon Baumann.

- ❖ The Pledge of Allegiance was recited.
- ❖ Motion by Lisa Baur, second by Dan Knetter to approve the printed minutes of the December 2, 2025 town board meeting. Motion carried.
- ❖ Treasurer Mike Maguire presented the financial report for January 2026. Tax collections totaled \$772,392.94, which is 42% of the total taxes levied. The electronic scanning of the tax checks worked fine after a few minor details were corrected. Tax settlements will be sent by the Clerk to the taxing districts. Motion by Knetter, second by Baur to approve the Treasurer's report. Motion carried.
- ❖ Motion by Baur, second by Knetter to approve payment of bills with check numbers 19074 through 19104, wages, and payments made electronically. Motion carried.
- ❖ Motion by Knetter, second by Baur to pay the schools, county, and NTC levies. Motion carried.
- ❖ Motion by Baur, second by Knetter to approve payment to the Mosinee Fire District for fire and ambulance coverage for 2026 in the amount of \$24,750.00. Motion carried.
- ❖ Motion by Knetter, second by Baur to approve the 2025 year-end financial report. Motion carried.
- ❖ Clerk's Communications & Reports:
  - No building permits were issued.
  - The Board was given their W2s and the Clerk mailed the 1099s.
  - The Clerk has filed the SOT form, the yearly housing report form, and the injury report form.
  - There will be no February primary. The next election will be held on April 7th, 2026.
  - The clerk will send in registrations for BOR training either in Marshfield on January 31st or Stevens Point on February 27th.

- The new DNR contact for our area is Jeremiah Schiefelbein. He will be contacted for a joint meeting with the Town of Cleveland for the Schuette Road culvert replacement project.
- The Clerk furnished the Board with a copy of the delinquent tax list.
- ❖ Chairman & Supervisors' Reports:
  - Projects for 2026 were discussed. These included a salt shed, additional hard rock replacement, and possible culvert replacements.
  - The Chairman received a few complaints about road conditions after the various ice storms. Several loads of gravel were applied to all Town roads to help make the roads safer.
  - An AI company has made initial inquiries to Town of Emmet residents regarding the possible purchase of land for the construction of massive AI facilities.
- ❖ Motion by Knetter, second by Bauer, to change the date for the next Town Board meeting to Monday, February 9th, 2026 at 7:00 PM. Motion carried.
- ❖ Motion by Knetter, second by Bauer to adjourn. Motion carried. Time: 8:20 PM.
