Minutes

Regular Town Board Meeting - February 9th, 2026

- ❖ The Regular Monthly Town Board Meeting of the Town of Emmet was called to order on the above date by Chairman Tyler Dahlke at 7:00 PM. The meeting was held in the Halder Community Hall, 135125 Halder Drive, Mosinee, WI. Present were Town Board members Tyler Dahlke, Lisa Baur, Dan Knetter, Mike Maguire, and Jerry Fitzgerald. The meeting date was changed due to a scheduling conflict.
- ❖ The Pledge of Allegiance was recited.
- ❖ Motion by Lisa Baur, second by Dan Knetter, to approve the printed minutes of the January 13th, 2026, Town Board Meeting. Motion carried.
- ❖ Treasurer Mike Maguire presented the financial report for February 2026. The February settlement was not available. Those levies will be paid when the information is received from the County Treasurer. Mike outlined the major bills. There were two tax overpayments. Motion by Knetter, second by Baur to approve the Treasurer's report. Motion carried.
- ❖ Motion by Knetter, second by Baur to approve payment of bills with check numbers 19105 through 19131, wages, and payments made electronically. Motion carried.
- ❖ Motion by Baur, second by Knetter to approve payment of the school, county, and NTC levies per the February settlement. The Clerk will send these checks. Motion carried.
- ❖ There was an agenda item for the Edgar Fire Department (2026 charge), however, that bill had not arrived at the meeting time. Motion by Knetter, second by Baur to pay the charge if the bill arrives before the March meeting. Motion carried.
- ❖ Motion by Baur, second by Knetter to authorize the final payment to the Board of Commissioners of Public Lands of \$54,391.05. Motion carried.
- ❖ Clerk's Communications & Reports:
 - The Clerk attended the BOR training on Jan. 31st, 2026. Board members are registered for the training on February 27th, 2026 in Stevens Point.
 - The State has allocated funds for the 60/20 culvert replacements. More discussion on this at the March meeting.
 - The Clerk filed the audit with the insurance company for 2025.
 - Contact has been made with the new DNR representative for this area. A meeting date will need to be set for culvert inspections and permit issue on Shuette Road.
- ❖ Chairman & Supervisors' Reports:
 - Board discussion on completion of Town Hall entrance project.
 - The subject of large AI centers was discussed. No action taken.
- ❖ Motion by Lisa Baur, second by Dan Knetter to change the date of the March meeting to Tuesday, March 3rd, 2026 at 7:00 PM at the Town Garage. Motion carried.
- ❖ Motion by Knetter, second by Baur to adjourn. Motion carried. Time: 8:17 PM.
