Regular Town Board Meeting

The regular monthly Town Board Meeting of the Town of Emmet was called to order on the above date by Chairman Tyler Dahlke at 7:00 PM. The meeting was held in the Town of Emmet Town Garage, 135103 Halder Drive, Mosinee, WI. Present were Town Board members Tyler Dahlke, Lisa Baur, Dan Knetter, Mike Maguire, and Jerry Fitzgerald. The meeting date was changed due to a scheduling conflict.

- ❖ The Pledge of Allegiance was recited.
- ❖ Motion by Lisa Baur, second by Dan Knetter to approve the printed minutes of the February 9th, 2026, Town Board Meeting. Motion carried.
- ❖ Treasurer Mike Maguire presented the financial report for March 2026. Due to the early meeting date, several bills will be paid after the meeting. Motion by Knetter, second by Baur to approve the financial report. Motion carried.
- ❖ Motion by Knetter, second by Baur to approve payment of bills with check numbers 19132 through 19149, wages, payments made electronically, and bills arriving after the meeting. Motion carried.
- ❖ The Edgar Fire Department charge for 2026 will be paid upon receipt.
- ❖ Motion by Knetter, second by Baur to approve the revised recycling ordinance. Motion carried. This will be put on the website.
- ❖ Motion by Baur, second by Knetter to approve the Wisconsin Towns Association resolution supporting increased funding for roads and other projects. Motion carried. The Clerk will forward this motion.
- ❖ Motion by Knetter, second by Baur to authorize printing of the annual report. The format will remain the same as in previous years. Motion carried.
- ❖ Motion by Knetter, second by Baur to authorize the Clerk to publish road materials and dust control bids. Motion carried. The published notice will be in the Town newspaper.
- ❖ Motion by Baur, second by Dahlke to approve operator licenses for Rachel Schmidt, Nicole Myszka, and Avery Haugen. Motion carried.

Clerk's Communications & Reports:

- ❖ No building permits have been issued since the last meeting.
- ❖ The Clerk will contact the DNR representative for permits for the Schuette Road culvert project.
- ❖ The spring election will be on Tuesday, April 7th, 2026.

Chairman & Supervisors' Reports:

- ❖ Depending on weather conditions, the Town Board will schedule culvert inspections on the 6/20 culverts. Tentatively, this will be the third week of March 2026.
